### I. Roll Call

# II. Approval of Minutes

After a correction on an excused absence, Mr. Craft entertained a motion to approve the Minutes of the November 23. 2015 meeting. It was so moved by Ms. Avalo and seconded by Ms. Rodriguez. The motion was carried and approved by the Committee.

### IV. Old Business

### **CHANGES TO WORKFORCE STATISTICS REPORTS**

Discussion continued from the last meeting about possible changes to the questionnaire portion of the County's Workforce Statistics Reports. One point to change would be that if any question on the Questionnaire portion of the report resulted in an answer of "Not Applicable", the department would need to provide an explanation. Discussion ensued regarding a Diversity or Recruitment plan from Human Resources. Staff will attempt to locate such a plan. This discussion is Tabled until the March 2016 meeting.

### **CHAIR-VICE CHAIR ELECTIONS**

### GENDER AND RACE STATISTICS ON MANAGEMENT VS NON-MANAGEMENT EMPLOYEES

The Committee reviewed the statistics sheet. Discussion ensued. It was noted that in terms of higher level management positions, Blacks and Hispanics are a lower percentage.

### VI. Workforce Statistics Reports

#### SHERIFF/CORRECTIONAL HEALTH

Dr. Stillson presented the 2016 Sheriff/Correctional Health's Workforce Statistics Report to the Committee. Discussion ensued. There were no further questions or comments from the Committee.

#### **REVENUE RECOVERY**

Dr. Stillson presented the 2016 Revenue Recovery's Workforce Statistics Report to the Committee. Discussion ensued. The Committee questioned the "Not Applicable" response on Questionnaire #3, "Please describe what recruiting and or informational events your department has participated in and how they help to ensure a workforce representative of Sacramento County." Staff will contact the department for clarification. There were no further questions or comments from the Committee.

#### **ASSESSOR**

Dr. Stillson presented the 2016 Assessor's Workforce Statistics Report to the Committee. Discussion ensued. There were no further questions or comments from the Committee.

Mr. Craft entertained a motion to approve the 2016 Workforce Statistics Reports for Sheriff/Correctional Health, Revenue Recovery and Assessor. The motion was so moved by Ms. Gallardo and seconded by Mr. Peterson. The motion was carried and approved by the Committee.

## VII. Open Discussion

The Committee was concerned about management level positions and the lower representation of ethnic groups in these positions. They discussed the possibility of reviewing applications for those promotional opportunities. Dr. Stillson explained that we could contact the Employment Office for exam statistics on particular job classes.

The Committee also discussed recruitment and job fairs. The departments look to Human Resources for organizing and scheduling job fairs. Invitations to departments or participation in job fairs, such as for the California State Universities, would be helpful. Another idea would be to create a central list of places to recruit from.

With no further questions or comments, Mr. Craft entertained a motion to adjourn the meeting. The motion was so moved by Ms. Avalo and seconded by Mr. Peterson. The meeting adjourned at 4:51 p.m.
