### MINUTES

- **Call to Order**

Martin Ross, EEOAC Chair, called the meeting to order with quorum at 3:35 pm. The following were present through roll call:

**Staff Present:** Cori Stillson, Edward Brown, Andrew Marotte, Toby Buonocore.

**Guest Present:** None

**Members Excused:** Matt Satow, Patrice Pratt, Annette Bedsworth, Patrick Hunter, and Monika Mejia. Mr. Ross entertained a motion to excuse absences. Ms. Robertson motioned to approve, and Mr. Lutz seconded. All others were in favor, and the motion carried.

- **Member Termination**

Mr. Ross entertained a motion to approve the dismissal of EEOAC member Monika Mejia for meeting attendance. Ms. Avalo motioned to approve, and Ms. Brown seconded. All others were in favor, and the motion carried. Ms. Stillson informed the committee that there are provisions in the bylaws that must be followed before action is taken. Agreement to approve the motion until clarification from the bylaws on next steps.

- **Approval of Meeting Minutes**

Mr. Ross entertained a motion to approve minutes. Ms. Robertson motioned to approve, and Ms. Avalo seconded. All others were in favor, and the motion carried.

- **Communication/Reports**
